Mr. Anthony Pinkham, Workforce Solutions Northeast Texas Board Chair, brought the Executive Committee meeting to order at 10:03 a.m.

Item 2. Determination of quorum

A quorum was determined to be present.

<u>Item 4.</u> Reminder of Texas Government Code Chapter 551 regarding open meetings that if a member of the public or of the Board inquires about a subject that is not on the agenda, and for which notice has not been given as required, any discussion of or decision about the subject of the inquiry shall be limited to a proposal to place the subject on the agenda for a future meeting.

Mr. Pinkham reminded the Executive Committee members that discussion of items other than those listed on the agenda is not allowed and a proposal can be made to place the subject on the agenda for a future meeting.

Item 5. Approval of the Executive Committee Minutes of April 22, 2021

Ms. Mary Dwight made the motion to approve the April 22, 2021 Executive Committee minutes. Mr. Adam Routon seconded the motion. All were in favor. None opposed. Motion carried.

<u>Item 6.</u> Appointment of Nomination Committee for the election of officers to be held August 2021.*

The Executive Committee appointed Dr. Larry Dotin, Ms. Irene Suarez, and Ms. Donna Dounley to serve on the Nomination Committee.

<u>Item 7.</u> Discussion and action, on behalf of the Full Board, regarding the Board Minutes of April 28. 2021.*

Since there was not a quorum at the June Full Board meeting, the Executive Committee took action, on behalf of the Full Board, on the agenda items requiring a vote from the June Full Board meeting.

Ms. Tammy Miller made a motion to approve the Full Board Minutes of April 28, 2021 on behalf of the Full Board. Ms. Dwight seconded the motion. All were in favor. None opposed. Motion carried.

<u>Item 8.</u> Discussion and action, on behalf of the Full Board, regarding the monthly financial reports.*

Mr. Randy Reed, Executive Director for Workforce Solutions Northeast Texas, reported the board was \$89,793 under budget as of May 31, 2021. Those significant variances include:

Personnel - \$45,134 under budget due to an employment vacancy in the accounting department. This variance will continue to increase as the position remains open through the end of the fiscal year.

Information Technology - \$6,780 over budget due to purchases of cybersecurity enhancements. This variance will decrease as the year progresses, but will remain over budget at end of year.

Strategic Initiatives - \$17,971 under budget due to when the events take place and how the line items are budgeted. This variance will decrease as the year progresses.

Travel – Board Staff - \$13,334 under budget due to travel restrictions as a result of the COVID pandemic.

Dr. Kevin Rose made a motion to approve the monthly financial reports, on behalf of the Full Board. Ms. Dwight seconded the motion. All were in favor. None opposed. Motion carried.

<u>Item 9.</u> Discussion and action, on behalf of the Full Board, regarding the Report on Audit of Financial Statements and Supplemental Information for the year ended September 30, 2020.*

Mr. Reed reported the audit was completed by Saunders & Associates and noted that in the firm's opinion, "the financial statements referred to above present fairly, in all material respects, the financial position of Northeast Texas Workforce Development Board dba Workforce Solutions Northeast Texas as of September 30, 2020, and the changes in its net assets and its cash flows for the year then ended in accordance with accounting principles generally accepted in the United States of America."

The total expenses for FY2020 were \$912,615 for administrative and \$14,332,737 for program for a total of \$15,245,352.

There were no findings or questioned costs reported. The report has also been filed with and accepted by the Federal Clearing House and Audit Resolution team at the Texas Workforce Commission (TWC).

Mr. Adam Routon made a motion to accept the Report on Audit of Financial Statements and Supplemental Information for the year ended September 30, 2020, on behalf of the Full Board. Ms. Miller seconded the motion. All were in favor. None opposed. Motion carried.

<u>Item 10.</u> Discussion and action, on behalf of the Full Board, regarding the establishment of the Self-Sufficiency Wage Levels for FY2021.*

• Revised Policy 1.0.0404A.02 Determining Self-Sufficiency Wage Levels
Subsequent to the June meeting, Mr. Bart Spivey, Mr. Roger Feagley, and Mr. Reed
discussed the methodology regarding the establishment of the Self-Sufficiency Wage Levels.

Staff is proposing a change to the methodology in the policy from the 25th percentile of all wages to the 85th percentile of the median wage.

Ms. Dwight made a motion to approve the revised policy, "Determining Self-Sufficiency Wage Levels," on behalf of the Full Board. Ms. Miller seconded the motion. All were in favor. None opposed. Motion carried.

• Self-Sufficiency Wage Levels FY2021

Based on the methodology revision, the Self-Sufficiency Wage Levels for FY2021 will change, as well. For a family size of 1, the Self-Sufficiency Wage Level is changing from \$22,700 to \$28,220. \$7,856 is added for each additional person in the family.

Ms. Dwight made a motion to approve the Self-Sufficiency Wage Level for FY2021, on behalf of the Full Board. Ms. Miller seconded the motion. All were in favor. None opposed. Motion carried.

Workforce Center Activity

Workforce Centers are open for in-person visits. The supplemental payments and additional \$300 payment for Unemployment Insurance (UI) recipients have been stopped, as of June 26^{th} , per the Governor.

April/May average numbers per week: 202 customers visiting the workforce centers 596 using remote services

June/July average numbers per week: Increase to 266 customers visiting the workforce centers Decrease to 507 customers using remote services

Staff continues to work closely with employers who are hiring and hosting hiring events.

o Child Care Impacts

1777 children are in care and there are over 500 children on the waitlist. There will be \$5.2 million allocated to Northeast to serve an additional 687 children; however, this funding is only allowed to be used for parents who are in three service industries: Restaurant, hospitality, and retail. The challenge Northeast has is that although there will be funds to serve 687 children, there are only 517 openings with the child care providers. Staff has reached out to providers who are not in the child care program in order to gain interest.

AT&T has completed the cybersecurity review. The final report will be provided after TWC Management has been briefed. During the initial review, staff was told Northeast ranks among the highest in the state. AT&T reviewed over 45 areas. Ultimately, TWC will assess the report and determine if funding needs to be allocated for security enhancements over the next 2-3 years.
